- B) Quotations must be in the enclosed prescribed Performa on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or their authorized representative. In case of signing of quotation by the authorized representative letter of authorization must be attached with the quotation. Quotation must be reach at the Santipur College, Santipur, Nadia, West Bengal, PIN- 741404 within stipulated time period.
- C) Rates must be quoted in Indian rupees and specified taxes extra if any must be written separately.
- D) Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
- E) No overwriting or cutting is permitted in the rate. If found, the quotation shall be

summarily rejected.

F) The rates quoted must be valid for **30** days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.


M) **Payment Terms**: Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the Santipur College.
